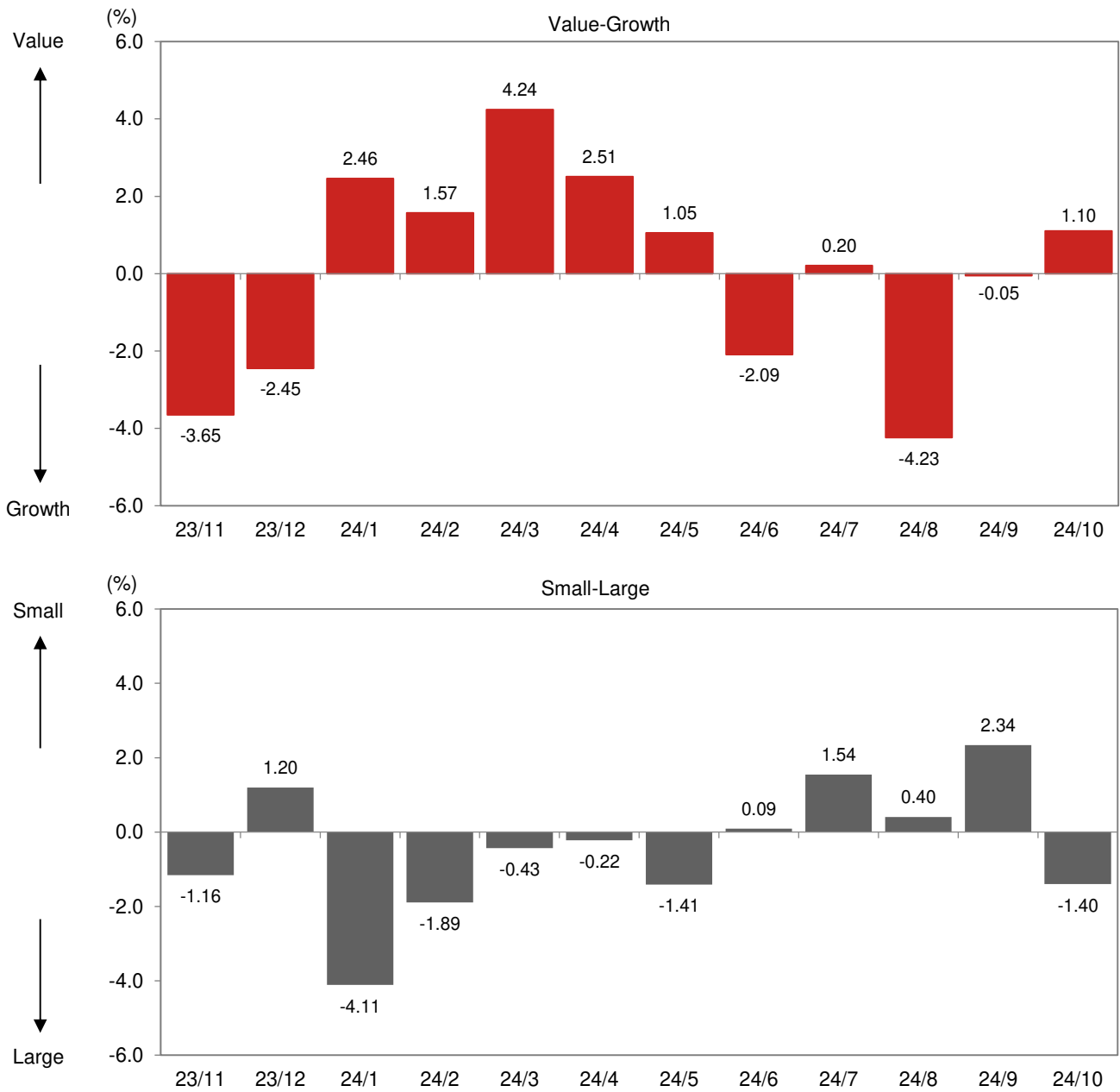

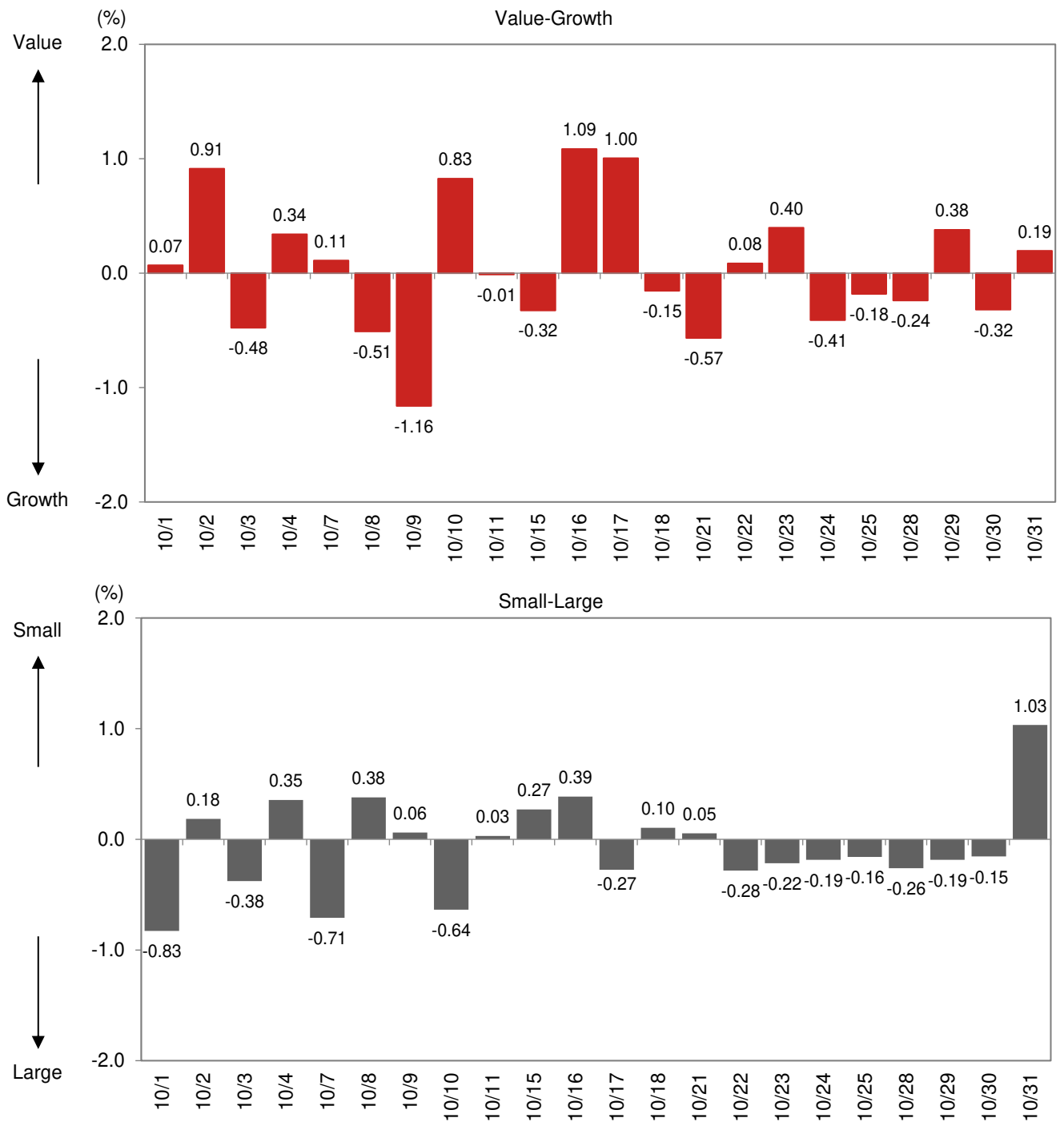
**Fig. 6: Monthly performance**

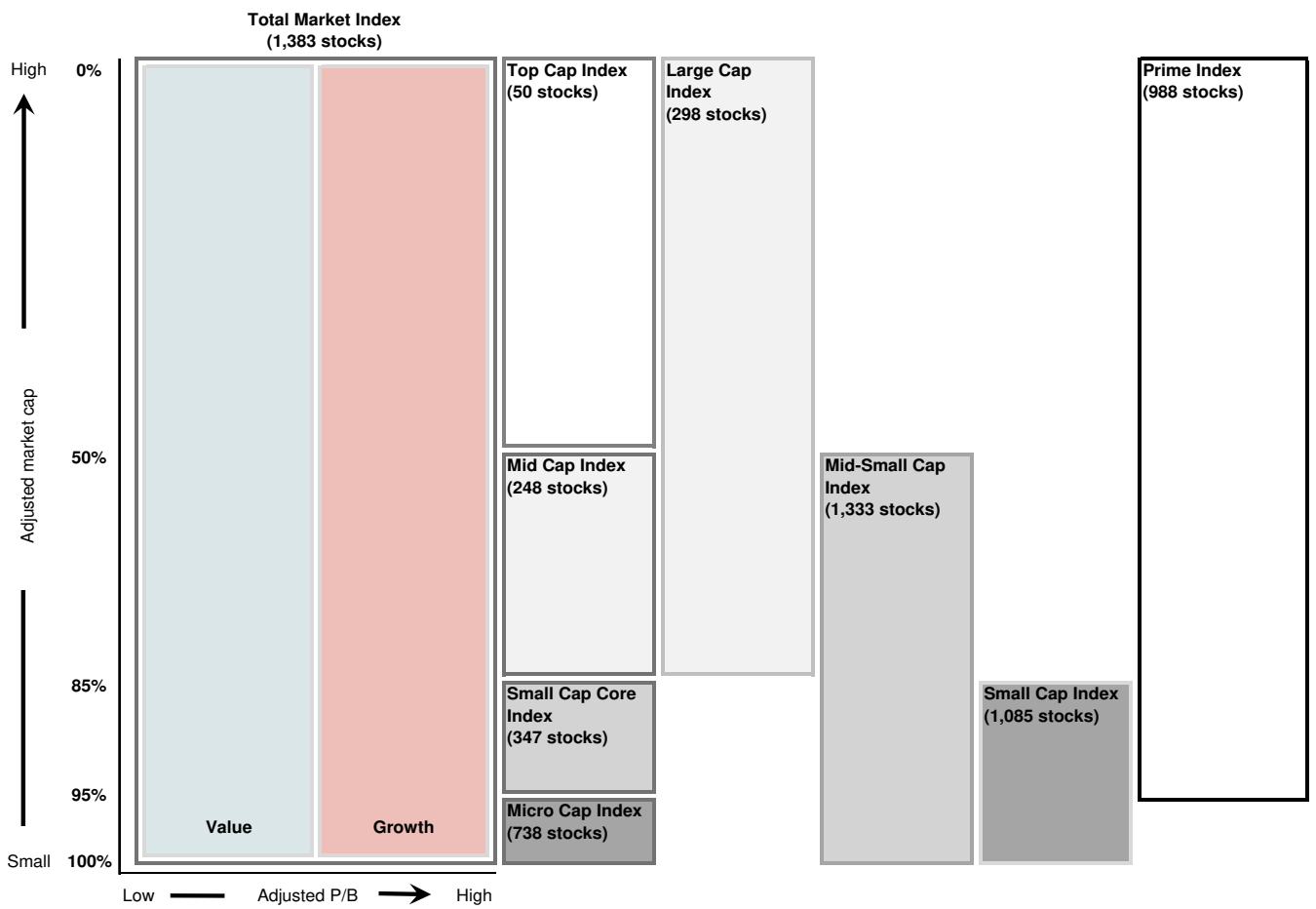
